Our November program is being organized jointly with the French-American Bar Association, whose members are also being invited. Our speaker will be Olivier Antoine, whose topic will be "Global Antitrust Enforcement: Who Runs the Show? The Revitalization of U.S. Antitrust Enforcement and the Rise and Prominence of Foreign Antitrust Regimes."

Mr. Antoine will discuss what changes the Obama administration has brought to U.S. antitrust enforcement, how such changes compare with recent actions by foreign antitrust regulators including the European Commission and the Chinese antitrust authorities, and what to expect in future trends in global antitrust enforcement. Mr. Antoine is a counsel at Crowell & Moring LLP in New York and has been involved in antitrust litigation and counseling before U.S. and European courts and before antitrust agencies in more than 30 jurisdictions outside the United States, including the European Union and its member states, Canada, Mexico, Argentina, Brazil, Chile, South Africa, Turkey, Russia, Japan, Korea, Taiwan and the People's Republic of China.
